It is the policy of Nevat Investments ("**we**", "**us**", "**our**", or "**Company**") to respect your privacy regarding any information we may collect while operating our website, [www.nevat.in](https://www.nevat.in). This Privacy Policy outlines how we collect, use, disclose, and safeguard your information.

We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the Terms and conditions posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

### Website Visitors

Like most website operators, "[www.nevat.in](https://www.nevat.in)" collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Nevat Investments' purpose in collecting non-personally identifying information is to better understand how Nevat Investments' visitors use its website. From time to time, Nevat Investments may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Nevat Investments also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on <https://www.nevat.in> blog posts. Nevat Investments only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

### Gathering of Personally-Identifying Information

Certain visitors to Nevat Investments' websites choose to interact with us in ways that require "Nevat Investments" to gather personally-identifying information. The amount and type of information that "Nevat Investments" gathers depend on the nature of the interaction. For example, we may ask visitors who conduct business on our website named <http://www.nevat.in> to provide a "**Name**", "**Email Address**", "**Demat Account Details**" and "**Bank Account Details**". This information is collected only with explicit consent and is stored using encryption and secure access protocols.

### User Information

To avail certain services on our Websites, users are required to provide certain information for the registration process namely: - a) your name, b) email address, c) mobile phone, d) sex, e) age, f) address, g) PIN code, h) Payment related details, and / or your occupation, interests, and the like. The Information as supplied by the users enables us to improve our sites and provide you the most user-friendly experience.



All required information is service dependent and we may use the above said user information to, maintain, protect, and improve its services (including advertising services) and for developing new services. Such information will not be considered as sensitive if it is freely available and accessible in the public domain or is furnished under the Right to Information Act, 2005 or any other law for the time being in force.

### **Security**

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we implement industry-standard measures to safeguard your data, no method of transmission or storage can be guaranteed as 100% secure.

### **Advertisements**

Ads appearing on our website may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by “Nevat Investments” and does not cover the use of cookies by any advertisers.

### **Information Sharing**

We may share the sensitive personal information to any third party without obtaining the prior consent of the user in the following limited circumstances:

- (a) When it is requested or required by law or by any court or governmental agency or authority to disclose, for the purpose of verification of identity, or for the prevention, detection, investigation including cyber incidents, or for prosecution and punishment of offences. These disclosures are made in good faith and belief that such disclosure is reasonably necessary for enforcing these Terms; for complying with the applicable laws and regulations.
- (b) We proposes to share such information within its group companies and officers and employees of such group companies for the purpose of processing personal information on its behalf. We also ensure that these recipients of such information agree to process such information based on our instructions and in compliance with this Privacy Policy and any other appropriate confidentiality and security measures.

### **Information Security**

We take appropriate security measures to protect against unauthorized access to or unauthorized alteration, disclosure or destruction of data. These include internal reviews of our data collection, storage and processing practices and security measures, including appropriate encryption and physical security measures to guard against unauthorized access to systems where we store personal data.

All information gathered on our Website is securely stored within our controlled database. The database is stored on servers secured behind a firewall; access to the servers is password-protected and is strictly limited. However, as effective as our security measures are, no security system is impenetrable. We cannot guarantee the security of our database, nor can we guarantee that information you supply will not be intercepted while being transmitted to us over the Internet. And, of course, any information you include in a posting to the discussion areas is available to anyone with Internet access.

However the internet is an ever evolving medium. We may change our Privacy Policy from time to time to incorporate necessary future changes. Of course, our use of any information we gather will always be consistent with the policy under which the information was collected, regardless of what the new policy may be.

## **Aggregated Statistics**
